A mistake will usually be raised as a defence to a claim of enforcement against that party for failing to perform (or for their anticipatory breach). On the other hand, a mistake of law cannot operate to void a contract. This is due to the principle of law expressed in the Latin maxim Ignorantia Juris non excusat. 1. Law of Contracts 1.1.
